
Substantial Revisions & Additions

- Clarification on:
 - · Giving and receiving gifts
 - Intimate relationships
 - Testimonials
 - · Electronic media
- Additions:
 - · Volume of supervisory activity
 - · Non-behavior analytic interventions



Revised ASD Practice Guidelines





Substantive Changes

- Registered Behavior Technician (RBT)
- Severe problem behavior
- Multiple models of tiered service delivery
- Supervision = "case supervision"
- Direct and indirect supervision activities
- More guidance on discontinuing services



Revised BCaBA Supervision Standards



Revised Standards

- Contract between BCaBA and supervisor now required
- Supervisor will be responsible for the work of the BCaBAs they are supervising
- Supervisor will be publicly identified on the Certificant Registry
- Supervision intensity now based on hours of practice
 - 2% of ABA services each month (full-time = 3.2 hrs/month)
- New BCaBAs more heavily supervised for their first 1000 hours of practice (5%)

Effective January 1, 2017



Maintenance Changes



- New inactive status available
- 90-day deadline for correcting expired certifications
- Changeover from 3-yr cycle to 2-yr cycle



BACB Newsletter





May 2015

- The BACB is pursuing national accreditation for the RBT credential + new exam
- There is an RBT training option for existing staff who have already been trained
- The 8-hr supervision training may be taken prior to certification & as part of a university course
